TÀPIES COMMISSION RULES WITHIN THE E.U.

Please, make sure to read all the information before applying.

The function of the Tapies Commission is to authenticate works of art attributed to Antoni Tapies and to issue the corresponding certificates of authenticity. For a work of art by Antoni Tapies to obtain a certificate of authenticity, it must abide by the following rules:

- 1. The Tàpies Commission will authenticate only original works. It will not authenticate graphic works, reproductions or dedications.
- 2. The Tàpies Commission will only authenticate and issue certificates to work that it examines directly. To this end the applicant must deposit the work at the Galeria Toni Tàpies, that will act as depositary, to be studied by the Tàpies Commission. The work should be sent to: Galeria Toni Tàpies, C/O Comissió Tàpies, C/ Consell de Cent, 282, E-08007 Barcelona.
- 3. The work must arrive at least one week prior to the meeting of the Tàpies Commission. The agenda for the meetings of the Commission during the year 2021 is as follows:

- 28 January - 29 April - 15 July - 25 November - 27 May - 30 September - 25 February - 16 December - 25 March - 17 June - 28 October

- 4. The work must be sent with all available technical documentation in order to facilitate its study by the Commission.
 - 5. The work must be sent unframed.
 - 6. The cost of both legs of the transportation must be borne by the Certificate's applicant.
- 7. At the moment of applying for the Certificate, the applicant must credit the Tàpies Commission's current account IBAN ES0201 8208 8060 0201525900. SWIFT CODE BBVA ES MM XXX (BBVA, Balmes, 256. E-08006 Barcelona) with the sum of 150 euros plus VAT in respect of the costs of registering the application.

The fees for examining the work and issuing a certificate are as follows:

Original work on canvas or wood and sculpture: 1.500 eurosplus VAT

Original work on paper: 750 euros plus VAT

If the work isn't signed by the artist, an amount of 2000€ plus VAT will be added to the corresponding fee.

By giving a VIES number (number of intra-Community transactions), the tax will be exempted. These fees must be paid upon notification by the Tapies Commission and before the work is returned and the Certificate issued.

- 8. The Tàpies Commission will issue only one duplicate certificate per work. In this case the standard procedure applies: an initial payment of 150 euros plus VAT for registering the application and a second payment in respect of issuing the document.
 - 9. As proof of acceptance, please return this document duly signed and stamped.
